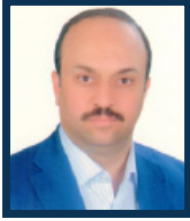
Iraq Private Banks League

- The consolidation of cooperation bonds between the members of the League and the preservation of their common rights and interests is among its most important goals, in addition to developing and qualifying human cadres in banks through participating them in training courses in order to modernize the banking business.

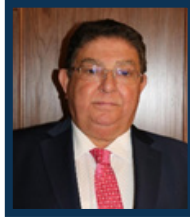

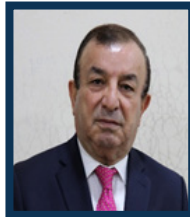

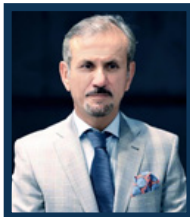
